oval (•) darkened to the left of the name of any candidate indicates a vote for that candidate. 3. Use only black or blue ink pen. 4. If you make a mistaké DO NOT ERASE. Ask for a new ballot. 5. WARNING: If you receive an absentee or mail-in ballot and return your voted ballot by the deadline, you may not vote at your polling place on Election Day. If you are unable to return your voted absentee or mail-in ballot by the deadline, you may only vote a provisional ballot at your polling place on Election Day, unless you surrender your absentee or mail-in ballot and declaration envelope to the Judge of Elections to be voided to vote by regular ballot.
