### Proposed Resolution Opposing FCC Actions to Abolish the Open Internet

WHEREAS the internet was created as a result of American taxpayer funding;

WHEREAS the airwaves are public property;

WHEREAS access for all to the internet is vital;

WHEREAS the new FCC chairman is an avowed foe of open access, and wishes to sell the right to govern & determine who may have what level of speed access to the internet by selling it to the highest bidder, rather than providing equal access in terms of message time;

WHEREAS those bidders' only interest is profit, and the FCC has proposed no regulations that would limit how the purchasers would govern their new internet kingdoms;

WHEREAS this will impede the speed at which libraries, small companies, individuals, universities and colleges, and other groups may access the internet;

WHEREAS this will put the "small players" at an even larger disadvantage;

WHEREAS granting speedy access to the wealthy will only give the wealthy more power and stymie development and innovation, further limiting our speed of knowledge acquisition at a time that other countries seek to improve their science and technology sectors;

WHEREAS the likely purchasers are Verizon and Comcast, companies which have not received the highest ratings for customer care or satisfaction;

WHEREAS there is neither any need to limit internet access, nor any benefit, nor any hurry;

BE IT RESOLVED that the Pennsylvania Democratic Party is opposed to the pending regulations that seek to take away equal and open access to the internet which has existed.

BE IT FURTHER RESOLVED that we ask all of our legislators to use their best efforts to halt the reckless sale of another public resource to the wealthiest corporations, and to preserve open and equal access to the internet, and to require that there be net neutrality for all.
